OVERVIEW

AccuSet[™] HIV-1 Group O Performance Panel 0800-0262 / Batch #10655753 is a 5-member validation panel of formulated human plasma samples representing unique HIV-1 group O isolates from Cameroon, USA, and Spain (1 vial per member, 1.2 mL per vial). Four panel members were prepared using AccuType[™] HIV-1 group O viral isolates diluted in defibrinated plasma (negative for anti-HIV-1/2, anti-HCV, HBsAg, and HIV-1 RNA). One non-reactive panel member (diluent only) is also included. Sodium azide (0.09%) was added as a preservative.

Test results from commercially-available HIV-1 RNA assays are included for characterization of the panel members.
