INTENDED USE

The AccuSet™ HBsAg Low Titer Performance Panel 0805-0370 is intended for use by diagnostic manufacturers, researchers, and clinical laboratories to develop, evaluate, or troubleshoot HBV test methods. Characterized samples and comprehensive data are provided for comparative analysis. For research use only. Not for use in diagnostic procedures.

PRODUCT DESCRIPTION

This product is a 20-member panel consisting of undiluted, naturally occurring plasma samples collected from individual donors positive for HBV infection with reactivities aimed towards the cutoff signal of commercially available HBsAg assays. Each sample represents a single collection event. No preservatives were added.

20 members, 1.5 mL per vial

STORAGE

Panel members should be stored frozen at -20 °C or colder. SeraCare recommends that the panel members be divided into smaller aliquots to avoid multiple freezethaw cycles, if appropriate. If turbidity or particulate matter is observed, the samples should be centrifuged in accordance with each test kit manufacturer's instructions for sample preparation.

INTERPRETATION OF RESULTS

The Data Sheet lists results for panel members generated using commercially-available screening, monitoring, and confirmatory test methods.
